Mr. Quigley then passed out a time clock policy for review.

Mr. Quigley will be speaking with Impullitti and Chagrin Watershed on the design for the veteran's project.

Ms. Blair attended the Kent State meeting for the Newbury-Berkshire school meeting; she indicated that they would need to consolidate while the schools are still in the black.
