Supplemental information may be requested as deemed necessary by the Township Zoning Inspector to insure compliance with the Newbury Zoning Resolution.

An insufficient funds fee of \$35.00 will be charged to the applicant for all returned checks.

I hereby certify that all of the information supplied in this application and attachments hereto are true and correct to the best of my knowledge, information and belief.

I hereby acknowledge that I understand that the penalty for falsification is imprisonment for not more than six (6) months, or a fine of not more than one thousand dollars (\$1000.00), or both.

I hereby consent to the inspection of the subject property and of any buildings or structures to be constructed thereon by the Township Zoning Inspector during construction and within thirty (30) days from the completion of any buildings or structures.

Lot lines shall be marked, building site staked and the Township Zoning Inspector notified one week before breaking ground on permits involving construction and also notified upon completion of construction.

I hereby acknowledge that I understand that if the construction or use described in the zoning certificate has not begun within twelve (12) months from the date of issuance or if construction has begun within twelve (12) months and said construction has not been completed within two (2) years from the date of issuance, said zoning certificate shall be revoked by the Township Zoning Inspector.

Note: The Township Zoning Inspector shall approve or disapprove this application within thirty (30) days.
